SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal

fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

• ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the

plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. In the space provided below, please describe the extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.

The Beacon City School District will continue the practices set up in the 2019-20 school year for cleaning and disinfecting schools and improving the air quality in the classrooms. Our cleaning protocols included Falsan solution, wipes, UV towers in the evening, and bioshield on surfaces. To address the ventilation we replaced unit ventilator filters with MERV 13 or comparable on a quarterly basis and continuing using HEPA filters in the classrooms. To encourage social distancing, we encourage our students to eat outside when the weather permits and purchased additional picnic tables, outdoor shade structures and rental of tents to encourage this. In the 2021-22 school year, we are utilizing American Rescue Funds to purchase MERV-8 filters for our unit ventilators, child and adult sized masks for our students and staff and plastic drinking cups for our portable drinking stations.

4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.

Beacon City School District will implement multiple forms of gathering data with the intent to continuously monitor student growth and needs. The district will use i-Ready diagnostic benchmark assessment as a tool for formative assessment. The data from this assessment which will be administered three times a year will be used in conjunction with Fountas and Pinnell Reading Diagnostic. The district will be streamlining their assessment tools with use of Fountas and Pinnell k-5 and gradually transitioning into grades 6-8. All teachers will receive Fountas and Pinnell kits as well as training in the administration of the assessment. The two assessments (i-Ready and F&P) will be used for data analysis to identify students needs and capture if there are disparities across subgroups. The information will then used to create an action plan of support and intervention. Once all data has been collected, students will received intervention to address learning loss in the following ways: (1) (all student) via the personalized student pathway of the i-Ready program, (2) thorough guided reading instruction based on their Fountas and Pinnell instructional level, (3) and students who are two to three grade levels below will received Academic Intervention Services (AIS). Identified students will also be eligible for after school remedial support services in the areas of concern for an additional hour a week for 20 weeks.

The Beacon City School District has hired three class size reduction elementary teachers to ensure lower class sizes. Lower class sizes allows the teachers to give more attention to students and access any additional academic supports they will need.

We are also using I-Ready program to assist in the assessment of students. IReady is a comprehensive assessment and instruction program that empowers educators with the resources they need to help all students succeed. By connecting Diagnostic data and Personalized Instruction, iReady reduces complexity, saves educators time, and makes differentiated instruction achievable in every classroom. Beacon is utilizing I-Ready through the administration of diagnostic assessments in both Reading and Math three times per year (October, January and May). The students are engaged in a personalized learning path that supports their individual academic levels. Teachers are also able to provide small group direct instruction lessons using the I-Ready resources that appear based on each student's area of need.

6. In the space provided below, please describe how the LEA will spend its remaining ARP ESSER funds consistent with section 2001(e)(2) - the allowable uses of funds - of the ARP Act.

The remaining funds will be used for facility type expenses which include the purchase of masks, filters for the unit ventilator systems and other protective gear needed during the COVID 19 pandemic. The funds will also be used for facility and operation repairs and upgrades that include upgrades to the unit ventilators in Glenham Elementary and JV Forrestal Elementary schools, upgrades to the fire alarm systems and public announcement systems in each school, upgrades to the HS auditorium to enable live streaming and other large group instruction, purchase of two generators, one at Rombout Middle School to ensure our backup server can function if there is a power failure at the HS and one at the bus garage to open garage doors if we lose power and be able to operate the gas and diesel fuel tanks. Lastly we are purchase kitchen equipment that has failed to ensure we can provide meals to our students.

The BCSD will utilize funds to support students within several subgroups through multiple avenues.

BCSD will implement the use of the i-Ready Reading and Math platforms. This digital platform will help us to support our ENL students whose home language is Spanish by providing supplemental support in both Reading and Math in Spanish. There are 3 diagnostic assessments administered throughout the year which can be administered in both English and Spanish. The results of the diagnostics creates an adaptive support curriculum that targets the areas of needs in Reading and Math. The program, because of its accessibility, adaptive component and its linkage to NYS standards can support students disproportionately impacted by Covid-19. The program is accessible after school hours and on weekends, if students have to quarantine or test positive for Covid-19, the lessons can be assigned to students to complete at home.

The BCSD is also committed to fostering an affirming and welcoming environment for all students. The funds will be utilized to purchase culturally authentic books that represented our student demographic. These books will support our students of color, who often don't see themselves reflected in the curriculum. The books will be used in guiding reading groups, as well instructional tools during Reading lessons.

Lastly, there will be books purchased that support our focus on Guided Reading. All teachers will receive guided reading books that will them to differentiate instruction for our special education, 504 and ENL students. The books will follow the Fountas and Pinnel leveling system that aligns with our literacy benchmark assessments. These book will enable small group instruction that will target to the specific needs of our SPED, ENL mnd 504 population.
