

# BEACON HIGH SCHOOL ATHLETIC HALL OF FAME

Established in 1996, the Beacon High School Athletic Hall of Fame provides an opportunity for the school to recognize athletes, coaches, and others for their outstanding athletic accomplishments or contributions to athletics at the district, local, state or national levels.

## Hall of Fame Goals

1. The Hall of Fame shall include fair representation of all sports in the Beacon City School District athletic program, including gender.
2. To induct all deserving individuals and teams who have properly submitted a Hall of Fame application, with proper documentation.
3. All those individuals and teams nominated to the Hall of Fame Committee shall be considered and voted upon.

## BY LAWS

### 1. Organization

Vacated committee members

- A. The Hall of Fame Committee shall be made up of the following individuals;
  - a. Three current coaches (male and female)
  - b. Two Hall of Fame members (male and female)
  - c. Two community members (male and female)
  - d. Two At Large
- B. The Director of Physical Education and Athletics or his/her designee shall serve as the facilitator of the committee and cannot vote
- C. If a position is vacated, the committee will make a recommendation to the director of athletics for a member/members they feel possess the background and appropriate qualifications to act as a committee member. If no recommendation is made, the director of athletics can make a recommendation to the committee to be voted upon. If in the event the committee is comprised of an even number of members, the director of athletics will be authorized to cast a vote in the process.

### 2. Nomination Process:

To be considered for nomination to the Hall of Fame, an application must be submitted with proper documentation that supports the nomination. Incomplete applications will NOT be considered and voted upon until proper documentation is submitted.

- A. Anyone can submit an application for nomination to the Hall of Fame Chairperson, Director of Physical Education and Athletics.
- B. Applications need only be made one time. Those not selected will be retained for future consideration.
- C. Nomination forms and specified supporting materials must be submitted in writing to the Hall of Fame Chairperson.

- D. Nomination forms shall be made available on the Beacon City School District Website and in the Beacon High Athletic Office.
- E. Those individuals submitting applications shall be notified in writing the status of their application and approval process.
- F. Applications can be submitted year-round to the committee with a July 1<sup>st</sup> deadline for the following induction ceremony.

### **3. Eligibility and Criteria:**

#### **A. Four Categories:**

Athlete Category - The athlete must have graduated Beacon High School to be eligible. An athlete can be for considered for induction after a minimum of five (5) years after date of graduation.

Coach / Administrator Category – must have been a coach or administrator in the Beacon City School District. A coach or administrator must be separated from the school district for a minimum of one year.

Honorary Category - An honorary candidate must have made a significant impact on Beacon High School and/or sectional, state, national, professional or international levels of athletics.

Team Category – a team is eligible after five (5) years.

- B. One of the inductees may be posthumous and left to the discretion of the committee.
- C. All applications must be accompanied by appropriate documentation;
  - a. Current Resume (include Beacon High School and post Beacon High School achievements and local, state or national recognition and honors).
  - b. Supporting materials (newspaper articles, internet information letters of recommendation from former coaches and/or players).
  - c. Other relevant supporting materials.
- D. The Hall of Fame Committee has the right to review, research and investigate all information provided.

### **4. Screening and Voting of Candidates:**

- A. All applications for each category shall be screened by the committee prior to any vote.
- B. The committee shall then vote by ranking the candidates from top to bottom with highest point value awarded to the top candidate.
- C. In order for a vote to take place there should be a minimum of (5) five committee members present.

### **5. Number of Inductees**

- A. There shall be a maximum of 5 individuals and 1 team inducted per year. At the discretion of the committee, additional inductees maybe considered.
- B. There shall be only one individual inducted from the Coach/Administrator or Honorary categories. The maximum number of individuals inducted shall be 5 (see letter A above).
